**Free Powerful Tools for Caregivers Series Returns**

MONTICELLO, NY - A nationally recognized, six-week educational program that provides family caregivers with the tools they need to increase their self-care skills and confidence will return in August. Powerful Tools for Caregivers (PTC) class series is offered by Cornell Cooperative Extension Sullivan County (CCESC) on Mondays, beginning August 22, 2016. Each class will be held from 4:30 to 6:30 pm in the Robert D. Norris Community Room of Ethelbert B. Crawford Public Library on 479 Broadway in Monticello. Light refreshments will be provided.

This free program aims to improve communication between the caregiver and the care receiver. Each individual learns to recognize the challenges of caregiving and the significance of better self-care skills. Dates will exclude Labor Day and include 8/22, 8/29, 9/12, 9/19, 9/26, and 10/3.

Bonnie Lewis, RN, dependent care educator of CCESC and Liliam Stettner, Clinical Social Worker, will help each participant to fill their caregiver "tool box" with self-care and stress reduction techniques. Lewis and Stettner are two of over 2,200 PTC class leaders that have been trained in 36 states.

Eight family caregivers graduated from a PTC class series offered by CCESC in May of this year, held at the Liberty Public Library. Since the program's inception, Powerful Tools for Caregivers materials have reached over 80,000 caregivers. 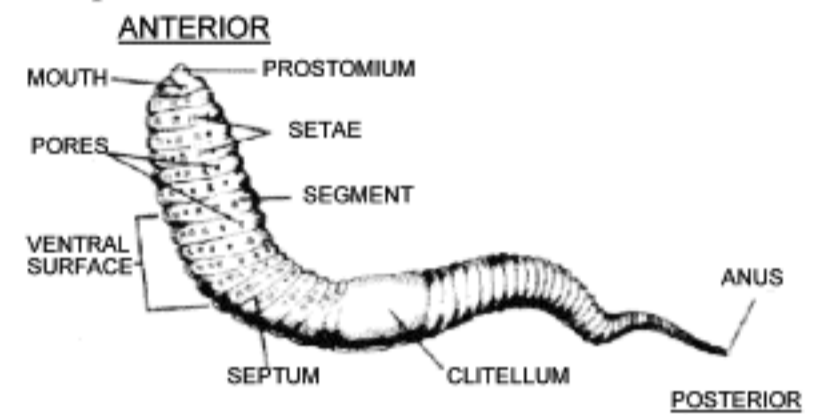

**More than a Fish Worm**

What has ten hearts, no eyes and eats dirt? It's a fish worm or more correctly an earthworm. Anyone prone to working the soil knows that turning the soil often exposes these shiny, wiggly pinkish-brownish tubular life forms.

One of the most familiar of them, the sort you may see in your garden, is commonly known as the Night Crawler (a/k/a Anglemorm or Rain Worm).

There are 3,000 different kinds of earthworm found worldwide, except in the desert. Those that live in the Arctic burrow through snow and ice. The worms that we see in the Catskills and throughout the eastern United States grow to about eight inches long, however, in Australia there is a giant species that can grow up to eight feet long! Earthworms are hermaphrodite (have both male and female parts) and reproduce by mating to exchange sperm cells to fertilize female eggs. The small white eggs are the size of a rice grain. Each is protected in a tough skin cocoon that is laid in the ground. The popular belief that a worm cut in half grows into two worms isn't true. Each piece is capable of re-growing only an over-cap of tissue - not a new head or tail.



The earthworm belongs to a group of animals called annelids which means "little rings" in Latin and refers to the many little segments that make up the worm body. The body of an annelid is usually divided internally and externally into well-defined segments which may be separated from each other by membranous partitions called **septa**. Except for the tail and head regions, all segments are essentially alike.

The body is a pinkish-red color and has two sets of muscles - one encircling the worm and the other running lengthwise. The earthworm crawls by alternately stretching and contracting these muscles. Each segment or section has muscles and bristles called **setae** that help move, anchor and control the worm when moving through soil. The bristles hold a section of the worm firmly into the ground while the other part of the body protrudes forward. The earthworm uses segments to either contract or relax independently to cause the body to lengthen in one area or contract in other areas. Segmentation helps the worm to be flexible and strong in its movement. If each segment moved together without being independent, the earthworm would be stationary.

Bundles of nerve fibers called **ganglia** lie in each body ring; four bundles linked together form a ring around the mouth. These are stimulated into eating by the five pairs of hearts encircling the esophagus.

An Earthworm usually extends its body from the surface opening of a small tunnel which it makes by "eating" its way through the soil. The rear end of the worm's body remains near the opening while the head end forages through decaying leaves and animal debris. Plants cannot use this organic matter directly. After organic matter is digested, the earthworm releases waste from their bodies called castings. Castings contain many nutrients that the plant can use.

Though having no visible eyes or ears, earthworms are very sensitive to light and vibrations, even footsteps. They stay underground by day to avoid drying out and feed at night, as all fishermen know from collecting this prime bait by the light of a flashlight.

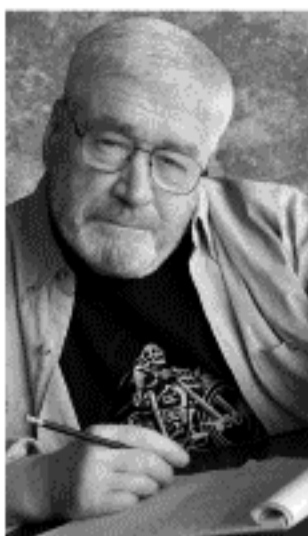
But Earthworms are much more than just fish bait. They are the main contributors to enriching and improving soil for plants and animals as they aerate the dirt to allow air, water and nutrients to reach deep within the soil. Worm burrowing also keeps topsoil loose.

Good dirt can support a million earthworms an acre that can overturn two hundred tons of earth annually!

Mysterious Book Report No. 249

With a renewed focus on Asia of late, it seems as though there's news and happenings on an hourly basis from the region. China, North and South Korea, Viet Nam, Cambodia, Burma, Taiwan, Tibet – and of course Japan, have all featured in the news recently – and why not? The majority of the world's population lives there, so it's vitally important for the rest of the world to know, and pay attention to, what's happening there, and acquire an understanding of their history and culture as well.

And hey – don't get in an uproar with your hair on fire – we're not gonna recommend a ten-thousand page Toynbee-type examination of the rise and fall of the Asian empires--this is about fun stuff like murder, and mayhem, and reckoning whodunnit. Along the way, we'll pick up a smattering of the art, culture and societal norms of modern-day Japan from a thriller writer with a firm grasp of eastern and western society.

*Pacific Burn*, (Simon & Shuster, \$25.00, 356 pages, ISBN 978-1-4767-9488-4) by Barry Lancet is the third installment in his astounding and amazingly good, award-winning series of thrillers featuring Jim Brodie. He's a bilingual San Francisco art and antiques dealer, specializing in Japanese artifacts. But Brodie's more than just a fine arts merchant. Much more. He's inherited a Tokyo-based, world-class detective agency from his estranged-and-deceased father, an on-call consultant for the SFPD, a martial arts expert, a widower and the single father of a six year old daughter.

As *Pacific Burn* opens, Brodie is called out by Lieutenant Renna of the SFPD Homicide unit to a death scene up in Napa, the heart of California wine country, where a small boy who speaks no English has been keeping an all night vigil alongside the body of an adult male. The Napa Sheriff's Department is ready to write it off as an accident at first, but the dead man turns out to be the eldest son of Brodie's friend and renowned Japanese artist Ken Nobuki, the very same man Brodie asked to be the featured artist for the Pacific Rim Friendship Program between Japan and the city of San Francisco. The boy, who's almost catatonic with fear, is his grandson. A week later, Nobuki himself is shot and critically wounded as he and Brodie exit City Hall. With his client in a coma and near death, Brodie races to save the rest of the family, from an unknown, and deadly enemy as he hunts for a legendary killer. The professional murderer--even if he exists is an elusive, mythical slayer whose reputation is powerful enough to frighten a hardened Yakuza assassin. The non-stop chase begins in northern California, goes to Japan then back to Washing D.C. as the hunt puts Brodie into ever increasing danger of losing his life. As with all of Mr. Lancet's books, interesting factual tid-bits about Japanese history, culture, art and society are sprinkled throughout this fascinating, fast-paced and excellent novel. A great summer read, you won't be able to put it down after reading the first page!

"It is our hope that visitors will come away with not only things to do in our area, but an appreciation of who we are as a community," noted the committee in charge of the effort.

### Ellenville CSD Alumni Hand Out Scholarships Association Supports Further Education & Music

Six graduating seniors were awarded scholarships of \$1,500 each at the recent Ellenville High School Senior Awards program, with the presentation by Dr. Richard Craft, president of the Ellenville/Wawarsing Alumni Association.

Since the first award was provided in 1999, members of the alumni association have given a total of \$65,300 in scholarships and 150 musical instruments (including a piano) to the music department; additional gifts have been made to the athletic department and the elementary school.

### Catskill Mountain Railroad Signs Multi-year Permit with UC to Operate on Kingston Segment of the Ulster & Delaware Corridor - Kingston Train Operations and Theme Trains Can Resume on August 1; Second Permit Allows Fall Foliage Trains in Mount Tremper for 2016 Season

Ulster County Executive Mike Hein today announced that the Catskill Mountain Railroad Company, Inc. ("CMRR") has signed a permit issued by the County to continue tourism railroad operations in the segment of the County-owned Ulster & Delaware (U&D) Corridor in the City of Kingston and Town of Ulster until the end of 2020. In addition, the CMRR also signed a temporary permit that would allow them to operate fall foliage trains in the Phoenicia-Mount Tremper segment for the 2016 season. Starting in 2017, the Railroad Explorers Corporation will begin operations in the Phoenicia-Mount Tremper segment and offer rail bike tours in the Corridor between Phoenicia and Boiceville.

Pursuant to the County Legislature's Resolution No. 488 of 2015, the County's Purchasing Department issued Requests for Proposal for two segments of the U&D corridor delineated by the Legislature for future rail tourism operations. Following a review process and interviews, the County selected CMRR as the operator for the "Eastern Segment," which runs approximately 9-miles roundtrip from the east side of the Kingston Plaza to Route 28A in the Town of Ulster. The available segment extends CMRR's prior operations by nearly 2 miles and allows for potential special events such as DAY OUT WITH THOMAS™ and THE POLAR EXPRESS™. The County Legislature selected Rail Explorers Corporation ("Rail Explorers") as the future operator for the "Western Segment," which extends approximately 6.2 miles from Boiceville to

Phoenicia. Rail Explorers currently offers rail-based tours on specially-manufactured "rail bikes" in the Adirondacks and the State of Delaware. Rail Explorers has proposed to begin rail bike tours in Ulster County in 2017; in the interim, CMRR will operate one additional season of fall foliage trains.

#### Ulster County Executive Mike Hein

"The Permit with CMRR is another important step in realizing the full potential of the U&D corridor," said County Executive Mike Hein. "This ensures that Ulster County residents and visitors alike can enjoy enhanced tourism railroad operations as well as public recreational uses, such as biking and hiking along the magnificent Ashokan Reservoir. The County has worked diligently to implement the Legislature's rail and trail policy for the U&D corridor, and we look forward to the success and benefits of both the rail and trail sections of this important County-owned asset."

"The Permit with CMRR offers an opportunity to turn the page on the robust and sometimes heated debate that has ensued over the past several years over the future of the U&D Corridor," noted Ulster County Legislature Chairman Ken Ronk. "We are moving forward in implementing the compromise "rail and trail" policy that passed the Legislature unanimously in December after many months of research, analysis and debate. The County is committed to the success of both the rail and trail parts of this compromise, and the issuance of the Permit to CMRR will allow the popular theme trains to resume in Kingston."

We welcome the public to join us for train rides and even to volunteer to support our continued growth in the coming years."

The Permit with CMRR is effective from August 1, 2016 to December 31, 2020. The County will now work on a similar permit with the Rail Explorers to begin operations starting in 2017.

### Marbletown Passes Plastic Straw Reduction Resolution, Urges Restaurants to "Offer First" - Resolution is

*First in New York State to Tackle Plastic Straw Waste*  
Marbletown, NY: It is unanimous. On Wednesday July 20th, the Marbletown Town Board "Straw Free Resolution" passed, making Marbletown the first municipality in New York State to tackle the extreme waste involved in over-consumption of

single-use plastic straws. The resolution positively affirms food establishments which "offer first" before serving single-use plastic straws in or with drinks.

Brigitte Nagle, of The Spy restaurant, social eatery and bar in High Falls, attended and spoke in favor of the Resolution, adding, "We already stopped using plastic bags for takeout," showing that restaurants are taking voluntary action on their own to reduce the plastic plague.

Stacy Sindt, co-owner of The Roost restaurant in Stone Ridge, supported the Resolution and commented today upon hearing it passed, "The Roost is honored to support this Resolution and delighted that it passed, to reduce plastic waste and protect our environment."

Though the resolution does not require restaurants to completely stop using plastic straws, one local restaurant has already taken that step. Scott Albright, owner of The Last Bite coffeeshop in High Falls, said, "Thank you for the information and opportunity to be a part of this movement. The Last Bite is join the ban and will no longer offer single-use plastic straws at the shop." Albright said a sign made out of plastic straws now reads, "NO PLASTIC," at his café.

Currently 500 million single-use straws are used and thrown away every day in the U.S., according to research based on industry production figures by the national "Be Straw Free" campaign, which believes the 500 million figure to be conservative. That amounts to wrapping the circumference of the earth 2.5 times per day with disposable straws and coffee stirrers.

"The World Economic Forum's report says that by 2050, there will be more plastic than fish by weight in the world's oceans," said Margot R. Becker, a member of the Marbletown ECC. "In the great plastic gyres in our oceans, the plastic bottles and straws become a broken down soup of tiny plastic particles that look like plankton. Fish, sea animals and birds eat this. It's just heartbreaking. And when fish eat plastic, then we do, too. We need to use less plastic. It's not that hard. It's not really a very big sacrifice. We just need to change our habits."

Marbletown Environmental Conservation Commission (ECC) Chair Tom Konrad commented, "Like most Hudson Valley communities, Marbletown's trash is currently hauled 250 miles to the Seneca Meadows landfill near Syracuse, at great cost. By asking customers if they want straws before providing them, local restaurants can cut their costs while reducing waste. As this resolution shows, the idea that all environmental goals require sacrifice is a straw-man."

Single-use plastic straws are manufactured with non-renewable resources, have a large cumulative carbon footprint, and add hundreds of thousands of pounds to U.S. landfills daily. Plastics production involves extracting petroleum products, usually using fracking -- unconventional deep drilling in shale rock - for ethane, a process which harms waterways, climate and health. Plastic straws are among the top 5 most common plastic items found in the oceans, according to NOAA (National Oceanic and Atmospheric Administration). Toxic chemicals - plasticizers, which are endocrine-disrupting chemicals -- are added to these plastics to make them more pliant. Ingesting plastic increasingly results in illness and death for seabirds, turtles, whales and other marine animals.

A number of Marbletown restaurants already minimize single-use plastic straw use; all expressed support for the resolution.

"We expect that dozens of other municipalities will pass similar resolutions, or stronger ones. This sweet earth, with its amazing waterways and oceans, its generous, life-supporting, threatened climate, is all we have," Bloom concluded.

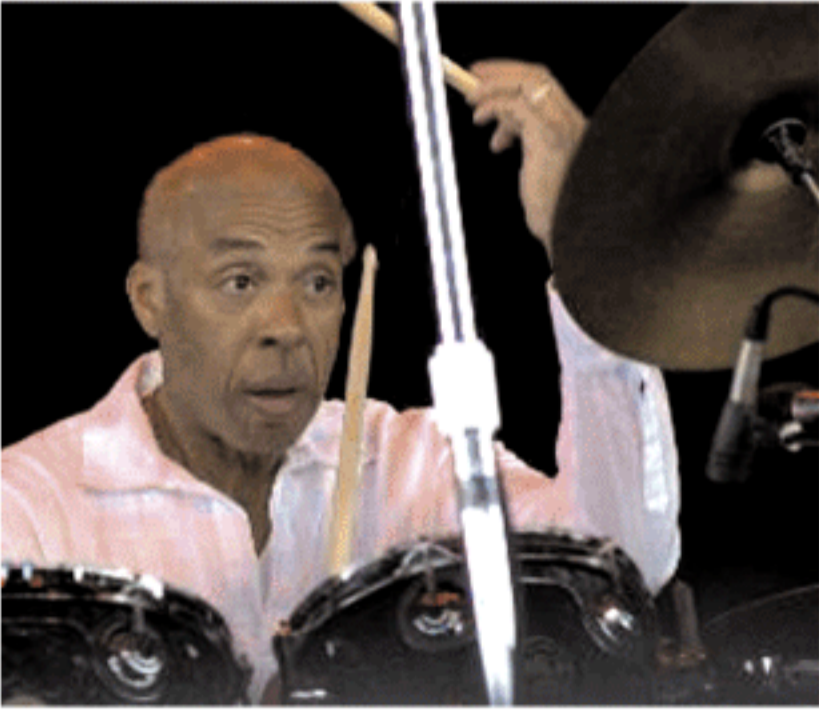

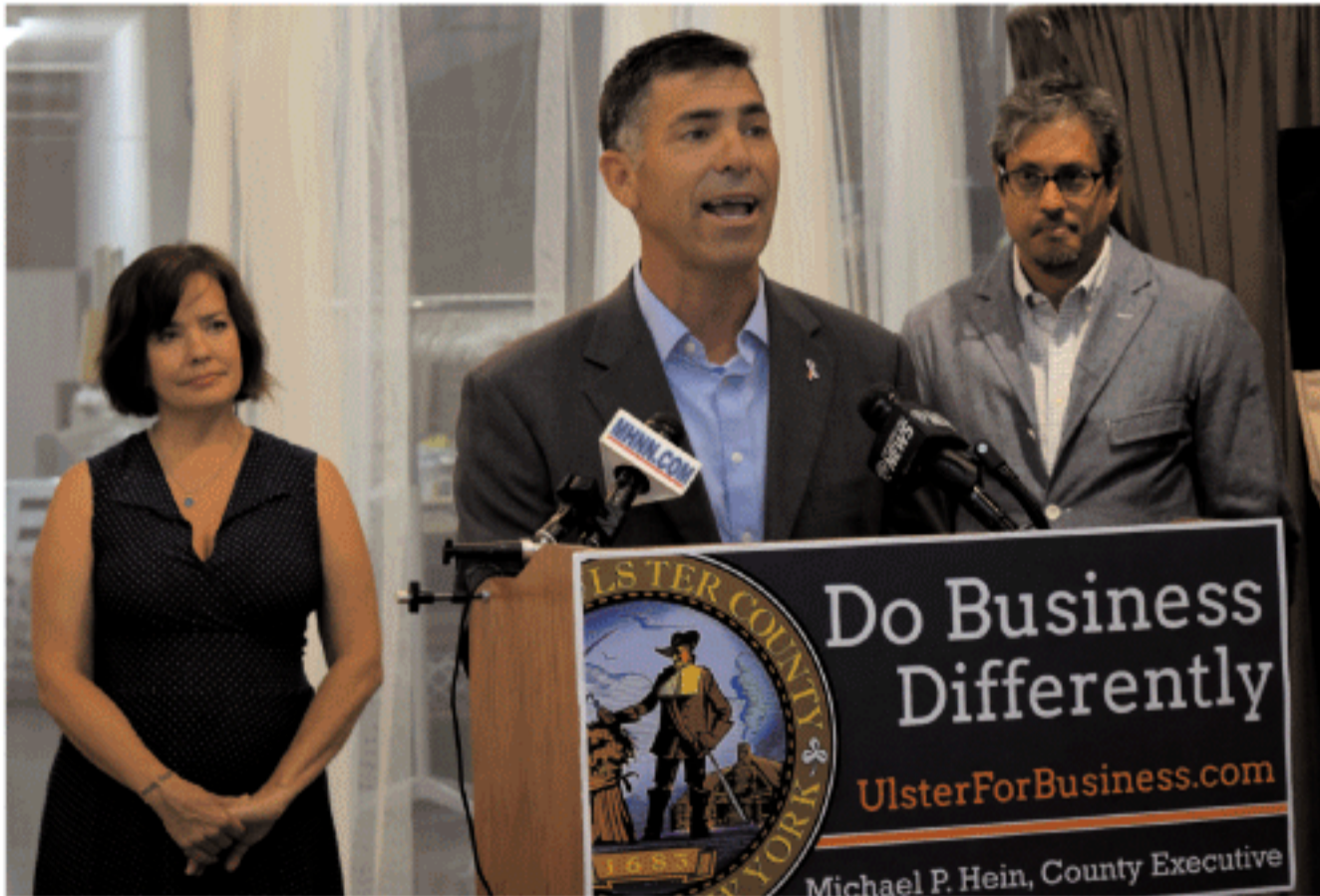

## Grants Will Offer Municipalities Relief From Unexpected Financial Costs - Part of Record \$300 Million Investment in Environmental Protection Fund Included in FY2017 State Budget

These grants, part of the FY2017 State Budget's record \$300 million investment in the Environmental Protection Fund, will mitigate the growing unexpected financial costs so that municipalities can recycle electronic waste efficiently and sustainably.

"New York State is a leader in protecting the environment and promoting sustainability, and the responsible recycling of electronic waste is an essential component of these efforts," Governor Cuomo said. "This funding will provide resources across the state to ensure cleaner communities for all."

## Senator Bonacic Recognizes the 26th Anniversary of the Enactment of the Americans with Disabilities Act

(Middleton, NY)-State Senator John Bonacic (R/C/I-Mt. Hope) issued the following statement on the upcoming 26th anniversary of the enactment of the Americans with Disabilities Act (ADA), which was signed into law by President George H.W. Bush on July 26, 1990. The law prohibits discrimination against those with disabilities in all areas of public life, including employment, schools, and public and private entities that are open to the public.

"The enactment of the ADA was an important moment in the movement for a better quality of life for individuals with disabilities," said Bonacic. "In most aspects of civic and community life -- education, housing, access to public venues, healthcare, even voting -- the ADA has brought about unprecedented improvements in the quality of life for people with disabilities. As an elected official, I am committed to ensuring that the ideals of the ADA are continuously being realized."

## Schneiderman Joins Justice Dept and Ten States Seeking to Stop Anticompetitive Merger Between Health Insurers Anthem and CIGNA - Merger Could Substantially Reduce Competition Among Large Employer Plans in New York And Nationally, Potentially Affecting Millions Of People, Including Hundreds Of Thousands of New Yorkers

**Schneiderman: My Office Will Do Everything Possible To Prevent Mergers That May Harm Patients By Raising Their Costs Or Reducing Access To Quality Healthcare**

Attorney General Eric T. Schneiderman announced today that New York has joined a joint federal/state complaint alleging that the proposed merger between insurance giants Anthem and Cigna would be anticompetitive and should be stopped. Anthem and Cigna are two of the top five national health insurance carriers in the United States, and Anthem is the second largest carrier in New York State. The proposed transaction has the potential to impact the accessibility, affordability, quality, and availability of health care for hundreds of thousands of individuals in the New York metropolitan area.

"Affordable, quality health care is essential to the well-being of all Americans," Attorney General Schneiderman said. "Most consumers are covered by insurance plans that their employers choose and negotiate with companies like Anthem and Cigna. By reducing competition, this proposed merger has the potential to significantly increase the merged firm's power in the marketplace, to the detriment of consumers. Employers will be left with fewer choices, and ultimately consumers could be saddled with higher premium costs, reduced access to providers, and lower quality care. I stand with my federal and state partners in fighting to stop this merger before it harms New Yorkers."

The lawsuit, which was filed today in federal court in Washington, D.C. by the Department of Justice, New York, ten other states, and the District of Columbia, seeks a court order halting the merger between the two companies. The complaint alleges that the consolidation would reduce competition for large-group employer plans in 35

local markets in which Anthem does business, including the New York City metropolitan area. It also alleges that the merger would reduce competition in the market for national plans sold to large employers covering employees throughout the country, including New Yorkers. In addition, it charges that the merger has the potential to drive down reimbursement rates for healthcare providers in a manner that might affect access to and quality of health care services in some areas of the country, including the New York City metropolitan area.

The case is being handled by Assistant Attorney General Irina C. Rodriguez of the Antitrust Bureau, under the supervision of Deputy Bureau Chief Elinor R. Hoffmann. The Antitrust Bureau is part of the Division of Economic Justice, led by Executive Deputy Attorney General for Economic Justice Manisha M. Sheth.

## New South Kortright Community Wastewater System is operational

Wastewater from individual septic systems in South Kortright, a hamlet in the in Delaware County Town of Stamford, is now being pumped to the Village of Hobart's Wastewater Treatment Plant through a project coordinated by the Catskill Watershed Corp. (CWC).

A \$5.7 million NYC-funded block grant from the CWC's Community Wastewater Management Program (CWMP) provided the funds to upgrade the Hobart plant and install a large diameter gravity sewer collection system that carries wastewater to the plant from 43 properties whose on-site septic tanks were decommissioned.

The project was designed by Lamont Engineers. The collection system, which can handle 20,000 gallons of wastewater per day, was constructed over the past year by F. P. Kane Construction, Inc. CFI Construction, Inc. handled installation of new pumps and storage tanks at the Village of Hobart WWTP, which was upgraded to handle 200,000 gpd (up from 180,000 gpd). Stirling Electric did the electrical work at the plant.

More than 4,000 linear feet of sewer main were laid. Grease traps were installed at two businesses and a church, and four 10,000-gallon emergency holding tanks were installed in two locations as part of this project.

The sewer district includes properties along Delaware County Road 18 from Madison Hill Road to NYS Route 10. Wastewater is pumped through a main that burrows beneath the West Branch of the Delaware River and Route 10 to a metering vault at the Allen Residential Center (ARC) before being pumped to Hobart.

The state-run ARC has long been connected to the WWTP. Operating responsibility of the pump station and forcemain has been transferred from the ARC facility to the Town of Stamford, which also inked an agreement with the Village of Hobart for use of the WWTP.

The new collection system will be turned over to the Town when final completion approval is given by the New York City Department of Environmental Protection (DEP). The DEP will provide operation and maintenance funds for both the collection system and the WWTP. Sewer district residents will pay a \$100 annual user fee to the Town of Stamford. Commercial entities will pay fees based on water use (a minimum of \$250 per year).

Although it is not located in the sewer district, South Kortright Central School will be connected to the new system, allowing it to abandon its deteriorating on-site septic tanks and leach fields. The school will pay the Town of Stamford an annual user fee.

"This is the eighth community to benefit from a wastewater treatment system constructed under the CWC's program," said Catskill Watershed Corp. Executive Director Alan Rosa. "These projects benefit the environment, give some peace of mind to residents, and make our hamlets more attractive to prospective new businesses and homeowners. We thank the people of South Kortright for their patience during this year of construction."

"Decades of data have shown that drinking water quality in New York City reservoirs has improved because of upgrades to wastewater collection and treatment in the watershed," DEP Acting Commissioner Vincent Sapienza said. "This new collection system in South Kortright will continue to protect drinking water while also providing reliable infrastructure for local residents and businesses in Delaware County. I'd like to thank CWC for guiding this project and many others like it."

F. P. Kane has moved its equipment to Lexington, Greene County where crews are installing laterals to 47 properties in another CWMP project. There, wastewater will be carried to a series of 18 absorption beds which were complet-

ed in 2015. The system is expected to be operational later this summer.

In the past 14 years, the CWC, under its Community Wastewater Management Program, has also developed septic solutions in the hamlets of Ashland, Bovina, Bloomville, Hamden, Delancey, Boiceville and Trout Creek.

Five more hamlets are in the planning or design phases: Claryville, Halcottsville, New Kingston, Shandaken and West Conesville.

The CWC is a non-profit, Local Development Corporation responsible for several environmental protection, economic development and education programs in the New York City Watershed West of the Hudson River. [www.cwconline.org](http://www.cwconline.org).

**'Objects' by Richard Gubernick at Alliance Gallery**

"Objects," an exhibit of sculpture by Richard Gubernick, opens with a reception on Friday, August 5 from 7 to 9 pm at the Delaware Arts Center's Alliance Gallery in Narrowsburg, NY. The exhibit will be on view through August 27.

The work in this exhibition involves the use of transparent plastic that was originally used as packaging material. The shapes in each piece of plastic are used as a starting point for composing.

"Initially, the transparent quality of the material appealed to me as a surface upon which I would apply layers of acrylic paint," Gubernick says. "Over time, the shapes themselves became more interesting to me." In some cases, Gubernick combines multiple plastic shapes to build new more complex forms.

"Early on, the process I developed required working the color in reverse, an absolute transformation of the traditional painting process," Gubernick explains. "What is visible on top had been applied first. Subsequent layers of paint would compliment and enhance the initial application."

His more recent work involves applying painted and printed paper using a collage process. This work emphasizes shape and constructed form.

Gubernick was born, raised and educated in the shadow of Yankee Stadium. He attended youth classes at The Museum of Modern Art in NYC. He obtained a BS degree from Buffalo State (SUNY) and an MFA from The University Of Massachusetts

Amherst. While an undergraduate, he was awarded a fellowship to the Yale-Norfolk Summer Art School where leading members of the "New York School" were visiting artists.

After being drafted into the Army and serving in The Counter Intelligence Corps in Europe, Gubernick taught painting for over 25 years at Buffalo State and is now retired. He lives with his wife Barbara Buckman (also a painter) in Youngsville, NY.

As a practicing artist, Richard has exhibited extensively with gallery affiliations in Buffalo, New York, Boston, Washington D.C., Pittsburgh, Ann Arbor, and Toronto. His work is in many corporate, private, university, and museum collections.

Gubernick also received several public art commissions including permanent installations at the Sky Harbor International Airport in Phoenix Az., Boston MBTA (subway) Buffalo (NFTA) Subway System and Central Florida University in Orlando, FL.

**Need New Inspiration in Your Life? This Healing Art Workshop Might Help**

Are you stuck in your personal or professional life? Make this upcoming "Healing Art Workshop" one part of the solution.

The Workshop, Aug. 7th at the Old Stone House of Hasbrouck, can't provide that new relationship or job right away, but its methods have been used for ages to aim lives in new directions. It uses "art journaling" and related techniques to help unlock hidden potentials, build self-confidence, and awaken personal energy and enthusiasm.

The Workshop "aims to help participants get in touch with the sub-conscious," says organizer Paulina Tracz, Art Director of the international Global Wellness Institute and a guiding force behind today's growing art journaling movement. "And that leads to accessing those inner patterns that mire us in situations our conscious minds are working to change."

A mere three percent of the brain's processing power deals with the conscious mind, according to Catherine Collaunt, Ph.D., a leading philosopher, writer, metaphysician, and manifesting consultant, while the remaining 97% operates in the sub-conscious. Says Tracz: "That's why life changes we want to make must be in alignment with both aspects of the brain in order to have an effect."

Many people carry unresolved issues from early childhood, Tracz says, "that result in sub-conscious patterns no longer serving us properly, and keep us stuck in unproductive situations."

Since such patterns can get solidly set even before kids speak their first words, so-called "talk therapy" may not be effective, or even discerned by the sub-conscious.

But even tiny infants recognize and understand the "language" of visual images, Tracz says, so art journaling "can access deeper and earlier emotions and inner messages that lie beyond the reach of spoken words and conscious thoughts."



Workshop participants are guided through a process of reaching their inner selves by use of meditation plus mixed-media art journaling, including collage, painting, drawing and writing. The act of creating artistic pages in a simple notebook, says Tracz, "brings forth messages often hidden from our conscious minds, allowing us to understand our earliest encoded patterns and work with them, rather than against them, to create the changes we seek."
